The meeting commenced at 5.55pm

**Speaker: Will Midgley – Midgley Motor Cars**

Will expressed thanks to those who came along to the showroom event. He explained that there were a couple of vehicles available for members to test drive, however before that he'd prepared a PowerPoint presentation which offered advice and information about the economic benefits of purchasing a hybrid car.

Will provided a description of how the car functioned, i.e. working from petrol or diesel in combination with the electric motor. He explained that there were a lot of misconceptions about the vehicle running out of electric charge and bringing the vehicle to a halt. He said in our more rural areas, there were not the stop fast charge points available, as in City areas, however, there were various methods available to recharge and the vehicle always had the more traditional backup method available for drive.

He explained that the Mitsubishi PHEV Outlander was currently the only four wheel drive vehicle which could run on electric and as such it was much sort after. For a 36 mile commute, this would be possible to run on just electric, however, for those travelling further, they would still use a portion of petrol or diesel propulsion and the economy of the vehicle was around 40 MPG.

Will went on to talk about grants available to businesses choosing to lease and purchase Hybrid vehicles.

These currently included a contribution to installation of the charger.  
To fast charge the vehicle would take 5 hours overnight and it worked out around £1 per night to do that.

Road tax was free. He explained that it was the only SUV which qualified for £5000 grant from the government.

There were tax benefits involved in running a hybrid vehicle also. Will handed out a comparison chart comparing the vehicle with the Audi & Avant to demonstrate.

Will also compared the vehicle to the Landrover Discovery and gave information about further grants and savings.

Will hoped that he had helped to explain the commercial benefits to business owners for looking at one of these vehicles as their fleet vehicle and answered any questions members had.

All present were impressed with the level of savings that could be achieved and eagerly anticipated test driving the vehicles.

The group was split into two. Alan Northrop Printers, Broughton Hall Estate and Craven Safety Services in one vehicle and Verner Wheelock Associates, C&H Brown and Urban Living Property Management grouped together in the other vehicle. They were asked to take images around Skipton as they test drove the vehicles and the winning group would be offered to take the vehicle home for a weekend.

On return the photographs were submitted to Wendy, Secretary. However, Will very generously offered all those present at the event the use of the vehicle for a weekend each. Members were very grateful for such an offer.
